Dear Mr. Hewitt:

Pursuant to the Minnesota Government Data Practices Act (Minnesota Statutes, Chapter 13), I write to request access to and inspection of the public portions of the following:

- □ All government data created, received, maintained or disseminated by Hennepin County Office to End Homelessness relating to the six goals identified in the ten year plan, including data by the community partner organizations and individuals identified in the 2006-2016 ten year plan.
- All government data created, received, maintained or disseminated by the office to end homelessness relating to the purview, operations, expenditures, staff and authority of the Hennepin County Office to End Homelessness.
- All government data created, received, maintained or disseminated by the office to end homelessness relating to the successful implementation of the Ten Year Plan targets, identified as follows;
 - 1. "Change the paradigm from *managing* homelessness to ending it, from *funding* programs to investing in the community, from serving people to *partnering* with people to achieve self-sufficiency."
 - 2. "Drastically reduce the number of shelter beds in our community, requiring only a few small shelters to address emergencies that cannot be resolved through prevention. People will be rapidly rehoused within two weeks."

3. "Eliminate panhandling and other livability issues through providing prevention and outreach services. Downtown businesses will thrive as more people both move downtown and come downtown to shop, play and attend Twins games."

Please be advised that I am prepared to pursue whatever legal remedy is necessary in order to obtain access to the requested records. Also, please note that willful violation of the Data Practices Act could result in the imposition of disciplinary action and the award of costs and disbursements, including reasonable attorney fees.
